Minutes of the Meeting held on April 17, 2014 At 100 W. Randolph Street, Chicago, Illinois

I. OPENING OF THE MEETING AT 10:00 A.M.

IV. BOARD ACTIONS

 Board of Trustees of the University of Illinois/Uni Faculty Organization, IEA-NEA Case No. 2013-RC-0008-S

Chairman Sered called the case. This was an appeal from an Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge. General Counsel Helen Higgins presented a memorandum prepared by the externs Matt Nagy and Jonathan Ludka recommending that the Executive Director's Recommended Decision and Order be affirmed. After discussion, the Board directed that an opinion and order be drafted in accordance with the recommendation.

Chicago Board of Education/Chicago Teachers Union (Brandon Smith) Case No. 2013-CA-0003-C

Chairman Sered called the case. This was an appeal from an Administrative Law Judge's Recommended Decision and Order dismissing the unfair labor practice charge. Associate General Counsel Susan Willenborg presented a draft order reversing the Administrative Law Judge's Recommended Decision and Order and remanding the case to the Administrative Law Judge for further proceedings. After discussion, the Board directed that an opinion and order be drafted affirming the Administrative Law Judge's Recommended Decision and Order, together with a concurrence.

McHenry Community Consolidated School District 15/McHenry Classroom <u>Teachers Association, IEA-NEA</u> Case No. 2014-AC-0001-C

Chairman Sered called the case. This was an unappealed Executive Director's Recommended Decision and Order granting the amendment of certification petition. General Counsel Helen Higgins presented the case, and, after discussion, Chairman Sered called for a motion for the Board not to take up the case on its own motion and to issue a final order. Member Ettinger so moved, and Member Prueter seconded the motion. The Board voted unanimously not to take up the case on its own motion and to issue a final order, by a voice vote.

Community High School District 94/District #94 Educational Support Staff Association, IEA-NEA Case No. 2014-UC-0003-C

Chairman Sered called the case. This was an unappealed Executive Director's Recommended Decision and Order granting the unit clarification petition. General Counsel Helen Higgins presented the case.
