Minutes of the Meeting held on April 21, 2016 At 160 N. LaSalle Street, Chicago, Illinois

I. <u>OPENING OF THE MEETING AT 10:00 A.M.</u>

II. <u>PRESENT</u>

III. ORAL ARGUMENT ON EMPLOYER'S REQUEST FOR PRELIMINARY <u>INJUNCTIVE RELIEF</u> <u>Chicago Teachers Union, Local No. 1, IFT-AFT, AFL-CIO/Chicago Board of</u> <u>Education</u> Case No. 2016-CB-0018-C

Chairman Waintroob called the case. The parties presented oral argument on the Employer's request that the IELRB seek preliminary injunctive relief. After the Board heard the parties' arguments, General Counsel Susan Willenborg recommended that the Board seek preliminary injunctive relief. After discussion, Chairman Waintroob called for a motion for the Board to seek preliminary injunctive relief. Board Member Prueter so moved, and Board Member Biggert seconded the motion. The Board voted 4-1 to seek preliminary injunctive relief, by a voice vote, with Board Member Sered dissenting. The Board directed that an opinion and order be drafted in accordance with its vote.

IV. APPROVAL OF MINUTES OF MEETING HELD MARCH 16, 2016

Chairman Waintroob called for a motion to approve the minutes of the March 16, 2016 Board meeting. Board Member Bigget moved to approve the minutes of the March 16, 2016 meeting. Board Member O'Brien seconded the motion. The Board passed the motion unanimously, by a voice vote.

1. <u>Chicago Board of Education/Alita Jones</u> Case Nos. 2015-CA-0044-C, 2015-CA-0051-C

Chairman Waintroob called the case. This case was before the Board on the Complaint's exceptions to the Administrative Law Judge's Recommended Decision and Order dismissing the complaint. General Counsel Susan Willenborg presented the case. After discussion, the Board directed that an opinion and order be drafted affirming the Administrative Law Judge's Recommended Decision and Order.

2. <u>University of Illinois, Urbana-Champaign/AFSCME, Council 31</u> Case No. 2015-CA-0017-S

Chairman Waintroob called the case. This case was before the Board on exceptions to the Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge. General Counsel Susan Willenborg presented a draft opinion and order written by Associate General Counsel Ellen Strizak affirming the Executive Director's Recommended Decision and Order. After discussion, Chairman Waintroob called for a motion for the Board to issue the draft opinion and order. Board Member Prueter so moved, and Board Member O'Brien seconded the motion. The Board voted unanimously to issue the draft opinion and order, by a voice vote.

3. <u>Chicago Board of Education/Esperanza Mora</u> Case No. 2015-CA-0035-C

Chairman Waintroob called the case. This was an unappealed Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge in its entirety. General Counsel Susan Willenborg presented the case. After discussion, Chairman Waintroob called for a motion for the Board to not take up the case on its own motion and to issue a final order. Board Member Sered so moved, and Board Member O'Brien seconded the motion. The Board voted unanimously not to take up the case on its own motion and to issue a final order, by a voice vote.

4. <u>Chicago Teachers Union/Esperanza Mora</u> Case No. 2015-CB-0012-C

Chairman Waintroob called the case. This was an unappealed Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge in its entirety. General Counsel Susan Willenborg presented the case. After discussion, Chairman Waintroob called for a motion for the Board to not take up the case on its own motion and to issue a final order. Board Member Sered so moved, and Board Member Biggert seconded the motion. The Board voted unanimously not to take up the case on its own motion and to issue a final order, by a voice vote.

5. <u>AFSCME, Council 31/Brown, et al.</u> Case Nos. 2015-FS-0033-S, et al.

Chairman Waintroob called the case. This was an unappealed Administrative Law Judge's Recommended Decision and Order dismissing the fair share fee objections. General Counsel Susan Willenborg presented the case. After discussion, Chairman Waintroob called for a motion for the Board to not take up the case on its own motion and to issue a final order. Board Member Prueter so moved, and Board Member Biggert seconded the motion. The Board voted unanimously not to take up the case on its own motion and to issue a final order, by a voice vote.
