## I. <u>OPENING OF THE MEETING AT 10:00 A.M.</u>

# II. <u>PRESENT</u>

The meeting was conducted via videoconference. Chairman Andrea Waintroob; Board Members Judy Biggert, Gilbert O'Brien, Michael Prueter and Lynne Sered; Executive Director Victor Blackwell; Acting General Counsel Susan Willenborg; staff member Ellen Strizak; and observer Sylvia Rios were present in Chicago, Illinois. Staff members Cindy Handy and Matthew Nagy, and observer Lisa Daykin were present in Springfield, Illinois.

## III. <u>APPROVAL OF MINUTES OF MEETING HELD AUGUST 20, 2015</u>

Chairman Waintroob called for a motion to approve the minutes of the August 20, 2015 meeting. Board Member Prueter moved to approve the minutes of the August 20, 2015 meeting. Board Member Biggert seconded the motion. The Board passed the motion unanimously, by a voice vote.

# IV. BOARD ACTIONS

#### 1. <u>Community Unit School District 300/La Vanda /Wheeler</u> Case No. 2015-CA-0040-C

Chairman Waintroob called the case. This case was before the Board on exceptions to the Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge. Associate General Counsel Ellen Strizak presented a draft opinion and order affirming the Executive Director's Recommended Decision and Order. After discussion, Chairman Waintroob called for a motion for the Board to issue the draft opinion and order. Board Member Prueter so moved, and Board Member O'Brien seconded the motion. The Board voted unanimously to issue the draft opinion and order, by a voice vote.

#### 2. <u>Local Education Association of District 300, IEA-NEA/La Vanda</u> <u>Wheeler</u> Case No. 2015-CB-0015-C

Chairman Waintroob called the case. This case was before the Board on exceptions to the Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge. Acting General Counsel Susan Willenborg presented a draft opinion and

order affirming the Executive Director's Recommended Decision and Order. After discussion, Chairman Waintroob called for a motion to vacate the Board's prior vote to issue a final order. Board Member Sered so moved, and Board Member O'Brien seconded the motion. The Board voted unanimously to vacate the prior vote to issue a final order, by a voice vote. Chairman Waintroob then called for a motion for the Board to issue the draft opinion and order. Board Member Sered so moved, and Board Member Biggert seconded the motion. The Board voted unanimously to issue the draft opinion and order, by a voice vote.

#### 3. <u>Moraine Valley Community College/Cook County College Teachers</u> <u>Union, Local 1600, IFT-AFT, AFL-CIO</u> Case No. 2014-CA-0017-C

Chairman Waintroob called the case. This case was before the Board on exceptions to the Administrative Law Judge's Recommended Decision and Order finding that the Employer had violated the Act. Acting General Counsel Susan Willenborg presented a draft opinion and order affirming the Administrative Law Judge's Recommended Decision and Order. After discussion, Chairman Waintroob called for a motion for the Board to issue the draft opinion and order. Board Member Prueter so moved, and Board Member Biggert seconded the motion. The Board voted unanimously to issue the draft opinion and order, by a voice vote.

## 4. <u>Big Hollow School District No. 38/Big Hollow Federation of Teachers,</u> <u>Lake County Federation of Teachers, Local 504, IFT-AFT, AFL-CIO</u> Case No. 2014-CA-0067-C

Chairman Waintroob called the case. This case had been removed to the Board by the Administrative Law Judge. Acting General Counsel Susan Willenborg presented a draft opinion and order dismissing the complaint. After discussion, Chairman Waintroob called for a motion for the Board to issue the draft opinion and order. Board Member Biggert so moved, and Board Member Sered seconded the motion. The Board voted unanimously to issue the draft opinion and order, by a voice vote.

#### 5. <u>Hinsdale Township High School District 86/Cassandra Gronewold</u> Case No. 2014-CA-0073-C

Chairman Waintroob called the case. This case was before the Board on the parties' Joint Motion to Forgo Enforcement of Order Requiring Posting. Acting General Counsel Susan Willenborg presented a draft order granting the motion. After discussion, Chairman Waintroob called for a motion for the Board to issue the draft order. Board Member Biggert so moved, and Board Member Prueter seconded the motion. The Board voted unanimously to issue the draft order, by a voice vote.
