Minutes of the Meeting held on April 18, 2013 At 100 W. Randolph Street, Chicago, Illinois

I. OPENING OF THE MEETING AT 10:00 A.M.

II. PRESENT

Chairman Lynne Sered; Board Member Gilbert O'Brien; Executive Director Victor Blackwell; Special Counsel John Brosnan; General Counsel Helen Higgins; staff members Colleen Harvey, Ellen Strizak and Susan Willenborg; and observers Dr. John Boyle, Jennifer Dunn, Melissa Reardon Henry, Takina Morris, Gail Mrzowski, Mike Persoon and Bob Shaevel were present. Board Member Ronald Ettinger, staff member Cindy Handy and observer Curt Richardson participated via video conference from the Board's Springfield office. Pursuant to Section 7(a) of the Open Meetings Act, 5 ILCS 120/7(a), Board Member Michael Smith, with prior approval, participated via telephone conference call due to illness, and Board Member Michael Prueter, with prior approval, participated via telephone conference call due to a weather emergency.

III. APPROVAL OF MINUTES OF MEETING HELD MARCH 21, 2013

Chairman Sered called for a motion to approve the minutes of the March 21, 2013 meeting. Member O'Brien moved to approve the minutes of the March 21, 2013 meeting. Member Smith seconded the motion. The Board passed the motion unanimously, by a voice vote.

IV. BOARD ACTIONS

Associate General Counsel Ellen Strizak presented a draft opinion and order denying the motion. After discussion, Chairman Sered called for a motion to approve the draft. Member Ettinger so moved, and Member O'Brien seconded the motion. The Board passed the motion unanimously, by a voice vote.

Chairman Sered called the case. This case was before the Board on exceptions to an Executive Director's Recommended Decision and Order dismissing the charge. Associste General Counsel presented a memorandum recommending that the Board affirm the Executive Director's Recommended Decision and Order. After discussion, the Board directed that an opinion and order be drafted in accordance with the recommendation.

Associate General Counsel Ellen Strizak, together with General Counsel Helen Higgins, presented a draft opinion and order affirming the Administrative Law Judge's Recommended Decision and Order. After discussion, Chairman Sered called for a motion to approve the draft. Member Prueter so moved, and Member O'Brien seconded the motion. The Board passed the motion unanimously, by a voice vote.

Chairman Sered called the case. This case was before the Board on exceptions to an Executive Director's Recommended Decision and Order dismissing the unfair labor practice charge. General Counsel Helen Higgins presented a draft opinion and order prepared by extern Danielle Stevens affirming the Executive Director's Recommended Decision and Order. After discussion, Chairman Sered called for a motion to approve the draft. Member O'Brien so moved, and Member Smith seconded the motion. The Board passed the motion unanimously, by a voice vote.
